

ORDINANCE NO. 2025-02

Synopsis: This ordinance, if adopted, will amend several sections of the code of Ordinances of the Town of Roanoke, Indiana to clarify and revise certain penalty provisions.

AN ORDINANCE AMENDING THE CODE OF ORDINANCES FOR THE TOWN OF ROANOKE, INDIANA

WHEREAS, the Town Council (“Council”) of the Town of Roanoke, Indiana, (“Town”) in meeting duly assembled, upon information deemed by it to be sufficient, including reports from its Town Marshal, finds that its Code of Ordinances (“Code”) should be amended to clarify and revise certain penalty provisions; and

NOW, THEREFORE, BE IT ORDAINED THAT the Town Code shall be and is hereby amended as follows:

SECTION I:

References to penalty sections in Town Code Sections 71.01, 71.02, 71.03, 71.04, 74.0, 90.02, and 110.02 shall each be amended to refer to the penalty provisions in Town Code Section 35.04.

SECTION II:

Section 35.04 of the Town Code is hereby replaced in its entirety with the following:

§ 35.04 SCHEDULE OF OFFENSES.

The following may be subject to admission of violation before the OVB:
