

**NOTICE OF PUBLIC HEARING ON PROPOSED ORDINANCE 2023-12 WHICH
WOULD AMEND SECTION 51.07(A) OF THE TOWN CODE RELATING TO THE
RATES AND CHARGES AND ADMINISTRATIVE FEE FOR THE COLLECTION AND
DISPOSAL OF SOLID WASTE AND RECYCLING**

BE IT KNOWN THAT, the Town Council of the Town of Roanoke, Indiana, will hold a public hearing at 6:00 o'clock p.m. the 19th day of December 2023, in the meeting room of the Town Hall located at 141 W. Third Street, Roanoke, Indiana, to consider whether to adopt proposed Ordinance 2023-12 which if adopted would raise the rates and charges and establish an administrative fee for the collection and disposal of solid waste and recycling which will partially cover direct and indirect current costs of that service.

That Ordinance 2023-12, exclusive of the whereas clauses, recitals of adoptions, and proposed signature block, reads as follows:

“NOW, THEREFORE, BE IT ORDAINED THAT Section 51.07(A) of the Town Code shall be and is hereby deleted and replaced with the following:

(A) A service charge and administrative fee shall be made monthly for the availability of the service in the collection and disposal of garbage and rubbish and recyclables per each active collection unit as follows:

Year	Service Charge	Administrative Fee
2024	\$16.25	\$ 0.50
2025	\$16.74	\$ 0.50
2026	\$17.24	\$ 0.50

BE IT FINALLY ORDAINED THAT this Ordinance amends only those portions of the Code specifically listed and shall be effective immediately upon its adoption all in accordance with Indiana Law.”

At that public hearing all interested persons may be heard concerning the proposed rates and charges and administrative fee set out in the proposed Ordinance and matters reasonably related thereto. The public hearing may be continued from time-to-time. After that hearing it is anticipated that the Council shall formally consider Ordinance 2023-12 either as originally introduced or as modified by Council.
